Since I last ran for Faculty Senate President there have been many changes at the college. The turnover of top administrators has been dramatic to say the least. As more and more money is spent on health care less is available for other services. Enrollment declines in west Tennessee have not helped either. One of my goals is to make sure that the money we do have is spent in the most effective manner and that the faculty has a say in these decisions.

I invite all faculty members to get active and participate in meetings and committees that foster change and not just change for change sake but actual improvements.
